### **QUALIFICATIONS**:

- $\checkmark$  Must be a member of the credit union with a primary account in your own name
- Must be attending an accredited college, university, or other institution of higher learning during the next academic year
- ✓ Must have a minimum grade point average (GPA) of 2.5
- ✓ Financial need

#### HOW TO APPLY: Read all instructions completely and thoroughly.

Please print legibly or type application and submit the following supporting documents:

- □ Copy of your most recent transcript and current cumulative GPA.
- □ A 1-page essay describing yourself, career goals, how you plan to achieve these goals, financial hardships, etc.
- □ Parent's/Guardian's most recent IRS tax return: *first 2 pages of 1040 only* (This applies if your parents claim you or you live at home). If your parent's income
  - has had a considerable change from the prior year, please note that within your personal essay.
- □ Student's most recent IRS tax return (If applicable). If your income has had a considerable change from the prior year, please note this within your personal essay.
- $\Box$  Your signed application
- □ Completed application packet can be mailed or dropped off at any CFCU branch office
