Changes in regulations and technology coupled with the significant decline in the demand for the Life Savings products has prompted CMFG Life Insurance Company, the underwriter, to discontinue these products by the end of 2014.

How will this affect you?

This will impact very few Catholic Federal members (see reverse side). Also, this does **NOT** impact any member-paid payment protection products including Credit Life and Credit Disability.

Per the terms of our contract, the group policy will expire on December 31, 2014.

Life Savings life insurance has been provided, at no direct cost to you, for eligible share deposits up to a maximum of \$2,000. Coverage on existing insurable deposits will end on January 31, 2015, the last day of the conversion period. Please destroy any CMFG Life Insurance Company Life Savings Certificate of Insurance you may have in your possession at that time. All Life Savings death benefit claims incurred on or before January 31, 2015 will be honored.

CMFG Life Insurance Company's decision to discontinue the Life Savings products impacts credit unions from all over the country. Here in our local area, members of Catholic Federal, Wanigas, and Wildfire credit unions will see their contracts expire.

We know many of you value the peace of mind and security that life insurance provides. You can convert your Life Savings coverage to a Primary Protection Plan, underwritten by CMFG Life Insurance Company. This new plan is a member pay, whole life plan up to \$2,000. If you apply by January 31, 2015, there are no age restrictions, waiting periods, exclusions, or health questions. If you convert, your new policy will be effective February 1, 2015 and premiums will be based on whole life insurance rates for your age on that date.
